Smarter Balanced Assessment (Math & ELA – grades 3-8, 10)	Required for Federal Accountability	Tests are not timed, so students can do their best and take breaks as needed. State Testing Window: March 4 – June 7, 2019 Test results are sent to parents in September the following school year.
Washington Comprehensive Assessment of Science (WCAS) (Science – grades 5, 8, 11)	Required for Federal Accountability	State Testing Window: April 15 – June 7, 2019
WA-AIM (ELA, Math & Science – grades 3-8, 10-11)	Required for Federal Accountability	State Testing Window: Oct. 17, 2018 – April 5, 2019
OSPI-Developed Assessments formerly known as Classroom Based Assessments (Social Studies – grades 3-12 The Arts – grades 3-12 Health and PE – grades 3-12 Educational Tech – grades 3-12)	Required for State Accountability (OSPI)	For each school year, school districts are required to report their implementation of assessments no later than June 30, 2019 . Teachers communicate assessment score as assessments are completed.
National Assessment of Educational Progress (NAEP) (Reading & Math – grades 4,8)	Required by Federal Law	NAEP selects schools by a stratified random sampling procedure; students in those schools are selected randomly. Individual score reports will not be provided to families.
English Language Proficiency Assessment for the 21st Century Screener (ELPA21) (Grades K-12)	Required by the State of Washington for English Language Proficiency	State Testing Window: Jan. 28 – March 22, 2019
WaKIDS – Washington Kindergarten Inventory of Developing Skills	Required by the State of Washington - WaKIDS isn't a test. Kindergarten teachers observe children during everyday classroom activities.	Before October 31, 2018 , teachers take an inventory of each child's developing skills in six areas: 1) Social-emotional, 2) Physical, 3) Cognitive, 4) Language & 5) Literacy. Assessment scores are available upon completion.
