2015-16 Letter to Household Family Income Survey

Dear Parent/Guardian:

As you may know, your child's school is now offering all meals at no charge. In order to help your child's school get the full amount of federal and state funding available to them and to make sure your child is receiving all the services they are eligible for, the school must have a way to identify children from households that are at or below the federal poverty level.

There are certain state funded programs (all-day kindergarten, learning assistance program, teacher incentives, and K-3 poverty) that are given to your child's school based on income levels of households for student's attending that school. This is why it is so important for you to return this information to your school. **Please complete this form as soon as possible and return to your schools office.**

Part 1.ELIGIBILITY: Look at the Income Chart below. 1.) Look for your household size and circle it. 2.) Calculate your total household income based upon how often you are paid and circle the amount closest to your income. 3.) Look at the row with your household size and see if the income is equal to or less than what is listed on the row for your pay period. 4.) **If it is**, then please **check the box** next to the household size. **If it is not**, then **Please check the box at the bottom of the form.** 5.) Turn the form over and fill out the remainder of the form and sign.
