INTRODUCTION AND BACKGROUND:

Grandview School District No. 200 is conducting a competitive bid process for **Enclosure of existing Pole Building Structure** for the **Grandview School District Storage Property** located at 710 W. Wine Country Road, Grandview, WA 98930. Select contractors listed on the GSD Small Works Roster are invited to provide quotes.

A non-mandatory Pre-Bid Conference has been scheduled for 12:00 p.m., local time September 9, 2019 at the project site 710 W. Wine Country Road, Grandview, WA 98930. Contact Pam Bullock 208-866-6808.

Prevailing wage requirement RCW 39.04.010 for Yakima County is required for this project.

TIMELINE

The contract period is expected to begin upon selection and extend through completion and close-out of the project. Construction activities are anticipated to begin in September 2019, with substantial completion by October 31, 2019.

Scope of Services: Enclosure of Pole Building - 46' wide x 126' long with 14' eave

- 1. Removal and disposal of any debris inside and within 5 feet of building. To include, demo of existing bird coop and any other debris in eaves, on walls and floor of structure. Slab to be cleaned thoroughly.
- 2. All existing electrical to be protected and to remain as is.
- 3. Addition of wall panels per structural letter, dated July 26, 2019 (see exhibit A.) **New metal siding to be Classic Rib, 24 ga. Ash Grey color with flashing.** Existing panels to main on South exterior and gable ends only.
- **4. Shear walls at East and West ends to be insulated and sheeted with OSB at interior**. See Structural letter. R21 faced insulation to be used. Field measure to verify.
- 5. Structure to receive flashing, trim and weatherproofing at openings as required to secure from elements and animals, at openings and where needed at existing metal panels, soffits, flashings.
- 6. No new interior sheeting, existing OSB to remain.
- 7. Walls with existing OSB to receive new exterior metal panel to be insulated during exterior panel removal. **R21 faced insulation** in these areas only. Area total is approximately 672sf, field measure to verify.
- 8. Existing soffit, flashing and roofing, to remain. Soffits and flashing to be repaired or replaced as needed to secure structure and keep birds from entering structure.
- 9. **Two (2) new insulated 12'x12' Overhead Doors**. Basis of Design Product: Overhead Door Corporation; Thermacore 190 Series. Manual opening. Reinforce truss structure at OH doors.
- 10. One (1) new exterior Hollow Metal, insulated (R-14) 3-0x7-0 Man door with passage HW and threshold. Basis of Design Product; Steelcraft, Ceco Door or Curries Company.
- 11. Two (2) new reinforced concrete ramps approximately, 5'x14'.
- 12. Contractor will leave site clean with all construction debris removed.
- 13. Permit will be by owner.
